THEY CAN ENJOY TRANSPORTATION TO AND FROM LOCAL HOSPITALS THREE TIMES PER DAY, HOME-COOKED MEALS, LAUNDRY FACILITIES, A BEDROOM WITH A PRIVATE BATHROOM, INDOOR AND OUTDOOR PLAY AREAS FOR CHILDREN, AND RECREATIONAL ACTIVITIES. FOR THE YEAR ENDED DECEMBER 31, 2014, 4,295 NIGHTS OF LODGING WERE PROVIDED, AND RENTAL DONATIONS BY GUESTS TOTALED \$9,350.

THE FAMILY ROOM PROVIDES A COMFORTING AND QUIET AREA OF RESPITE, RELAXATION, AND REFLECTION FOR FAMILIES AND LOVED ONES OF CHILDREN WHO ARE BEING TREATED IN THE CRITICAL CARE UNITS (NEONATAL INTENSIVE CARE UNIT AND PEDIATRIC INTENSIVE CARE UNIT) OF THE HOSPITAL.
